Candela Et.al., has defined a digital library as "an organization which might be virtual, that comprehensively collects, manages and preserves for the long-term rich digital content and offers to its user communities specialized functionality of the content of measurable quality and according to codified policies." (Sen Madhumay, Gaurav Kumar Jain, Ravi Ranjan, 2013) According to Gladney H. M. et. al. (1994) "A digital library service is an assemblage of digital computing, storage and communications machinery together with the software needed to reproduce, emulate and extend the services provided by conventional libraries based on paper and other material means of collecting, storing, cataloguing, finding and disseminating information." (Singh)

3. Aims of Digital Library:

6. Components of Digital Library:

The most important component of the digital library is open source software, Internet connection etc. Through these open source software library and the information centres regulate functions of digital library. With four steps digital libraries are conduct its functions. 1) User Interface, 2) Repository, 3) Handle system, 4) Search System (Sandip Das, M. Krishnamurty, 2014)

6.1 User Interface

User Interface is a system consists of computers, machines, software application etc. through the users visit and interacts with the library. Its key function is to connect the users with the machines. A digital library must provide a single point of access to a huge quantity of digitized information that is available to a diversity of kind patrons. User interface of a digital library has two roles, one for the end-user and another for the Librarians. The end-users and even a user from remote area will be able to access the same user interface of the library and its collection and another user interface for the librarians and administrators who manage and build the collection.

6.2 Repository

Repository is a storage location and where the information has been preserved or stored. In the digital library, digital content and metadata is stored in the repository which is computerized. The interface to repository is called the Repository Access Protocol (RAP).

6.3 Handle System

Library has its unique technique to locate and retrieve any books or document in the library. With the help of accession number to each document they can locate and retrieve easily the available documents or books in the library. In this same way Handle system is used as an identifier of digital resources. Digital information should have unique locator or identifier to retrieve from the web environment. Handle system consist of two parts: it's naming authority and a unique local name under the naming authority. handle/1989/21 In this 1989 is naming authority and 21 is the item identifier. (Sandip Das, M. Krishnamurty, 2014)

6.4 Search System

As we know that any document is not available for us without search. If someone wants a particular information or document of books he needs to search it on the searching system. Search system is a software system allows us to search for information on the World Wide Web. With the help of search system users can visit any document available in the repository of the library. Digital Library must make available such types of search system which allow the users to search their required information. The types of search services provided by the digital libraries with variety of content formats that should be included in a digital library platform. (Henry, 2012)

7. Advantages of digital library:

- 1) Unlike to traditional library digital libraries have the capacity to storage much more information in digital form and the huge information can be stored in the limited space.
- 2) Digital library does not need much more physical space to store the books.

9. Limitations of Digital Library:
